Our most commonly asked questions about the **Service Pupil Premium - 2020**

What is the Service Pupil Premium (SPP)?

£310 per Service child to provide additional support in recognition of the impact of mobility and deployment on their lives.

Q Is my child disadvantaged because they do not attract SPP in Northern Ireland, Wales or **Scotland?**

No. Education is a devolved responsibility and therefore the **Devolved Nations have developed** their own systems for supporting Service children - it does not mean that your child will not receive the support that they need.

Are children of reservists eligible?

If the Serving parent(s) are FTRS Full Commitment then their children are eligible.

No other form of Reserve Service is eligible.

OSo what can schools spend the money on and how do we know what they are doing?

The funding is primarily designed to provide pastoral support

It is often more straightforward for schools with larger numbers of Service children, and hence larger amount of funding, to offer specific and widespread support but there are things schools with lower numbers can do too. See table below for a few examples.

The school decide what to spend the money on. We encourage them to have information available on their website although formal guidance on whether they have to do this is unclear. If you can't find the information, it might be worth asking the question.

How do I get it for my child?

The premium is paid to schools and it is for schools to decide how it is best spent.

Let your school know that your child is a Service child before January each year (especially important if you have moved schools). The school submits the numbers to DfE in a January census return.

The school will not immediately receive the funding – it is paid in the following September. Note - this means that if your child joins a school in February 2021, they will not be included in a census return until January 2022 and SPP funding for them would not be received until September 2022.

Are our children eligible after we have left the RAF?

Yes - if your child has been flagged whilst you have been serving, they are eligible under something called 'Ever 6 Service Child'. As long as a child has been flagged as a Service child since 2016 (and prior to the Service person leaving the RAF) they will remain eligible for SPP for a maximum of 6 years or Year 11 (whichever comes first).

O I don't think our school is doing anything for my child/Service children with the money - what can I do?

Try to have a constructive dialogue with the school. Share guidance material that

If that doesn't work then your best course of action is to write to the Board of Governors with your concerns.
